On or about September 8, 2019, in the City and County of Honolulu, State of Hawaii, KAPONO J. MIRANDA, did intentionally or knowingly cause the death of Alan Jennings, thereby committing the offense of murder in the Second Degree, in violation of Sections 707-701.5 and 706-656 of the Hawaii Revised Statutes. If convicted of this offense or any included felony offense, KAPONO J. MIRANDA may subject to sentencing in accordance with Section 706-660.1 of the Hawaii Revised Statutes where he had an a semiautomatic firearm in his possession or threatened its use or used the semiautomatic firearm while engaged in the commission of the felony, whether the semiautomatic firearm was loaded or not, and whether operable or not. If convicted of this offense or any included felony offense, KAPONO J. MIRANDA, may be subject to sentencing in accordance with Section 706-661 and Section 706-662(4)(a) of the Hawaii Revised Statutes where he is a multiple offender in that he is being sentenced for two or more felonies or is already under sentence of imprisonment for any felony, and an extended term of imprisonment is necessary for the protection of the public.

Detective Donn Manzano hereinafter referred to as the "affiant" first duly sworn on oath, deposes and says:

That he has reason to believe that the offenses of Murder in the Second Degree, Place to Keep Pistol or Revolver, and Carrying or Use of a Firearm in the Commission of a Separate Felony have been committed and that the perpetrator of said offenses is Kapono J. Miranda;

That Murder in the Second Degree is in violation of Sections 707-701.5, Place to Keep Pistol or Revolver is in violation of Section 134-25, and Carrying or Use of a Firearm in the Commission of a Separate Felony is in violation of Section 134-21 of the Hawaii Revised Statutes;

That the facts tending to establish the grounds for the issuance of warrant of arrest for the said Kapono J. Miranda is as follows:

That your affiant is a resident of the City and County of Honolulu, State of Hawaii; that he is a police detective employed by the Honolulu Police Department and has been so employed for over the past 23 years; that he is presently assigned as a detective to the Criminal Investigation Division and has been so assigned for over the past five years; that

your affiant, in the course of performing his assigned duties, has investigated numerous crimes involving felony crimes and has so testified in the Courts of the State of Hawaii;

That your affiant is currently assigned to the Homicide Detail of the Criminal Investigation Division;

On September 8, 2019, your affiant was assigned by Lieutenant Deena Thoemmes to conduct a felony investigation into the arrest of Kapono J. Miranda for Murder in the Second Degree, Place to Keep Pistol or Revolver, and Carrying or Use of a Firearm in the Commission of a Separate Felony under HPD Report Numbers 19-340027-001, 19-340027-002, and 19-340027-003;

That based on your affiant's review of the initial patrol reports, interviews, and followup investigations that resulted in the positive identification of Kapono J. Miranda as the suspect in this case, your affiant's investigation to date has determined the following facts, circumstances, and information to the best of my knowledge and belief:

- 1. On September 8, 2019, at about 01:12 a.m., uniformed HPD officers were dispatched to the upper level parking lot of the Ala Moana Shopping Center on a report of two males fighting and that one had been shot. As Officers were enroute to the scene, additional information provided by police dispatch was that one of the men had been shot in the chest.
- 2. The scene was later determined to be the third level parking lot, fronting the Lucky Strike Social Honolulu (hereinafter "Lucky Strike"), located at 1450 Ala Moana Boulevard which is located within the City and County of Honolulu, State of Hawaii.
- 3. Officers arrived and they discovered a large crowd circled around the victim. The victim, later identified as the decedent, Alan Chase Jennings (hereinafter "Jennings"), was found with a single gunshot wound to his upper chest.
- 4. Jennings was taken to Queen's Medical Center where he died of his injuries. Pronouncement of Death was made by Doctor Jae Won Lee at 01:50 a.m. on September 8, 2019.
- 5. HPD Officer Jared Spiker (hereinafter "Officer Spiker") was flagged down by bystanders who immediately told him Jennings had been shot. A female witness, later

- identified as Christine Kaimi (hereinafter "Kaimi") informed Officer Spiker she had recorded the shooting with her cellular phone.
- 6. Kaimi turned over her cellular phone to Officer Spiker which showed the male suspect, later identified as Kapono J. Miranda (hereinafter "Miranda"), wearing a black long sleeve shirt and long blue jean pants.
- 7. Miranda was captured on cellular phone footage pointing what appeared to be a small black handgun in the direction of Jennings who at the time had his hands raised up in the air.
- 8. As the video continued, Miranda who appeared to be standing approximately five feet away from Jennings, appeared to have fired one round in Jennings direction, and Jennings appeared to be struck in the chest. Jennings slouched over, held his chest, and turned away from Miranda and started to run in the opposite direction. Miranda appeared to rack the upper slide of the handgun and shot a second time in the direction of where Jennings had fled out of camera view. Miranda then placed the handgun in his waistband and walked in the opposite direction of Jennings.
- 9. After viewing the cellular phone footage obtained from Kaimi, Officer Spiker updated police dispatch of Miranda's clothing, description, and direction of flight, which appeared to be in the direction of the Target Store. Officer Spiker described Miranda as "a local male wearing a long sleeve black shirt and blue jeans."
- 10. Officer Christopher Nutter (hereinafter "Officer Nutter") who was responding to the scene had heard Officer Spiker's update over the police radio. Officer Nutter checked the Target Store driveway leading out onto Kapiolani Boulevard. He observed a male matching the description given by Officer Spiker, run across the street in front of his subsidized police vehicle.
- 11. Miranda who came from the Makai side of Kapiolani Boulevard, ran across the street towards the parking lot of the First Hawaii Bank, located at 1580 Kapiolani Boulevard. Officer Nutter observed Miranda and immediately pulled his vehicle over and instructed Miranda to sit on the ground near the entrance leading into the bank parking lot.
- 12. As Officer Nutter exited his vehicle, an Ala Moana Security Officer later identified as B.S. Bisaram (hereinafter "Bisaram") informed Officer Nutter he had been following Miranda from the Target Store parking structure.
- 13. Miranda was not cooperative at the time and repeatedly stated to Officer Nutter the he was the victim. Officer Nutter attempted to gather information from Miranda as to the circumstances surrounding the injury to his mouth. Miranda told Officer Nutter "they shot me in the face" and "I'm the fucking victim boss, you guys chasing the wrong guy." Miranda told Officer Nutter "just imagine getting shot in the fact and you guys acting like I'm the criminal." Miranda initially provided his name as what sounded like "Kapono Pao."

- 14. Officer Spiker responded to the bank parking lot where he informed Officer Nutter that the male shooter in the cellular phone footage matched that of Miranda. Officer Nutter then informed Miranda he was being detained.
- 15. Miranda was later identified by his Hawaii State ID by Officer Spiker as "Kapono Miranda."
- 16. Due to the detainment of Miranda as a possible suspect, patrol officers conducted a field show-up, in which multiple witnesses identified Miranda as the male who fired a firearm at Jennings.
- 17. Officer Ryan Seto (hereinafter "Officer Seto") assisted in conducting a sweep of the parking structure and path which Miranda had taken on foot for any possible evidence to the crime. Officer Seto spoke with Security Officer William Moore (hereinafter "Moore") and asked him to point out where he observed Miranda. Officer Seto observed a black a 2017 Toyota Tacoma pickup truck, bearing Hawaii License Plate TTV127 in the area of where Miranda had been seen. Officer Seto observed multiple large drops of what appeared to be blood throughout the parking structure. Officer Seto further observed a black colored "P80" handgun within the bed of the black 2017 Toyota Tacoma. The vehicle was parked within the Mauka Diamond Head NE (Target Parking Lot) level 2B row A, within stall number 15 of 29.
- 18. Upon closer inspection of the handgun, Officer Seto recognized the firearm to be the brand label for a Polymer80, which is a company that sells Glock like plastic frames which can be made into live firing handguns.
- 19. On September 8, 2019, I obtained a recorded statement from Symplee Efhan (hereinafter "Efhan"). Efhan stated that on September 8, 2019, he met up with bunch of his friends including Jennings and Dustin Gapusan (hereinafter "Gapusan") at Lucky Strike at the Ala Moana Shopping Center. Efhan stated that they were waiting outside of Lucky Strike for a friend, when the "one boy," later identified as Miranda, came walking out of Lucky Strike along with two to three other males. Efhan stated that Miranda was walking and "looking dunk" and giving them "stink eye." Efhan stated that Miranda and Jennings were trading words when Miranda told Jennings "Yup, come over here." The males that were with Miranda were told Miranda "let's leave already." Efhan couldn't really see what was going on, but stated that he observed Gapusan hit Miranda. Efhan stated that he saw Miranda look down towards his waist and pull something out. Efhan could only see the butt of the gun. Efhan then ducked as he heard one gunshot and then a second gunshot. Efhan stated that he went around the corner and saw Gapusan trying to pull Jennings towards a car. As Efhan tried to help Jennings, he stated that he observed Miranda running towards the parking structure. Efhan positively identified Miranda to the police as the person that shot at Jennings. Efhan also identified the handgun to Police saying it "seemed like the right gun" recognizing the silver clip on the butt.

- 20. On September 8, 2019, I obtained a recorded statement from Gapusan and he stated that he is friends with Jennings and met him, as well as other friends at Lucky Strike at Ala Moana Shopping Center. Gapusan said about eight of them were waiting outside the door when three boys walked out of Lucky Strike. Gapusan stated that he personally knew two of the males, but had not previously met the male, later identified as Miranda, who was acting aggressively towards them. Miranda was "eyeing up" Jennings and they soon "got into it" and looked as if they were going to fight. The other males who were with Miranda told Gapusan "don't go, he get one gun." Jennings followed Miranda to the parking lot as others were talking about Miranda having a gun. Gapusan followed and observed Miranda playing with his shirt and suspected that Miranda had a gun. Miranda pulled up his shirt and reached into his pants and Gapusan observed the butt of a gun. Gapusan felt threatened and scared for Jennings and felt that he had to intervene. Gapusan hit Miranda and Miranda pulled the gun from his pants. Gapusan stated that he ran and heard two to three gunshots. He looked back and saw Jennings fall on his face on the ground. Gapusan stated that he grabbed Jennings and pulled him next to a car because Jennings had fallen in the middle of the road. Gapusan positively identified Miranda to the police as the person that shot at Jennings. He further identified the handgun to Police saying it "is the same gun he seen on his (Miranda) waist."
- 21. Markette Cadiz-Felton (hereinafter "Cadiz-Felton") provided Officer William Meredith (hereinafter "Officer Meredith") with a written statement. Cadiz-Felton related he was driving within the parking lot near Lucky Strike when he observed an altercation between two males. Cadiz-Felton observed one male throw a punch and the male suspect wearing a "black long sleeve and jeans took a couple steps back and draws a gun from his front waist and shoots two to three times." Cadiz-Felton positively identified Miranda to police as "the male shooter."
- 22. On September 8, 2019, I obtained a recorded statement from Security Officer, Willuth Luther, He stated that at about 0030 hours, he was assigned to secure the area near Lucky Strike. When he was near the front of Lucky Strike he noticed a group of guys surrounding one guy and they were talking about fighting. Luther observed the group walk towards the parking lot. Luther saw one of the guy use his right hand to punch another guy (Miranda) in the mouth. Luther observed Miranda back up a couple steps and reach into his pants under his shirt and pull out his gun. Luther observed Miranda shoot "the guy" (Jennings) that was in front of him. Luther knew that Jennings was shot as he put his hand on his chest. Luther observed smoke on the tip of the barrel of the firearm that Miranda was holding, and also observed that the tip of the firearm was silver. He then heard a second shot and ran for cover. Luther saw Jennings on the ground with people around him, so he went to try and help. Luther identified Maranda to police as the shooter.
- 23. On September 8, 2019, I obtained a recorded statement from Security Officer B. S. Bisaram. He stated on September 8, 2019, he was patrolling near another establishment, Mai Tai Bar, when he heard over the security radio that "somebody just fired off a gun!" Bisaram ran to the area of Lucky Strike and he observed a male, later identified as Miranda, who was wearing a black t-shirt and blue jeans, walking down

the ramp. Bisaram chased after Miranda and caught up to him. Miranda's mouth was bleeding as he told Bisaram "I'm the victim, I'm the victim" and that he had been shot in the mouth. Bisaram tried to grab Miranda's arm but he yanked it back saying "I know my rights, I cannot be detained!" Miranda continued walking and down the ramp toward Kapiolani Blvd., and Bisaram followed Miranda down the ramp to the street. Bisaram saw Officer Nutter and waived him down, at which point Officer Nutter stopped and detained Miranda.

- 24. Amy Villahermosa (hereinafter "Villahermosa") provided Officer Jozlyn Harrington (hereinafter "Officer Harrington") with a handwritten statement. Villahermosa related she was sitting in a car when she observed a tall male, later identified as Miranda, who was wearing a black shirt get punched. Miranda stepped back and pulled a small gun from his pants and shot at the male victim, later identified as Jennings. Villahermosa believed Miranda's first shot may have missed Jennings, in which Miranda fired a few more times. Villahermosa stated that she believed that Jennings was shot, after which, she observed Jennings run away. Villahermosa related Miranda fled the area, as she and her friends performed CPR until a trauma nurse arrived. She positively identified Miranda as the male shooter by his black shirt, tattoos on his neck, and the injury that he sustained to his face. Villahermosa also identified the gun as the same black firearm that she observed in Miranda's pants.
- 25. Shaelyn Borromeo (hereinafter "Borromeo") provided a handwritten statement to Officer Harrington. I also conducted a recorded interview with Borromeo on September 8, 2019. Borromeo related she was on the roof top parking lot next to Lucky Strike with her friend who was videotaping the incident with her cellular phone. Borromeo observed a fight break out, during which she observed a male, later identified as Miranda, back up and pull a gun from his waistband area and shoot once. Borromeo heard and observed Miranda shoot Jennings twice. Borromeo stated that she observed Miranda walk in the direction of Target and approach security guards, point in one direction, and when the security guards drove away, Miranda ran into the parking structure in the opposite direction. Borromeo immediately ran over to Jennings, at which time she applied pressure to his wound. Borromeo positively identified Miranda to police as, "the male that shot the guy." Borromeo identified Miranda through his neck tattoo and his clothing. Borromeo also identified the firearm that was used because it was black and small.
- 26. Based on the witness statements obtained and the positive identification of Miranda as the suspect who shot Jennings, Officer Spiker initially placed Miranda under arrest for Attempted Murder in the Second Degree. It was not until Pronouncement of Death made by Doctor Jae Won Lee at 01:50 a.m., that the Attempted Murder in the Second Degree was reclassified to Murder in the Second Degree.
- 27. Miranda was then informed by Officer Spiker of the reclassification of the offense and that he was now being placed under arrest for Murder in the Second Degree.
- 28. Scientific Evidence Specialist Doryn Matsuda (hereinafter "Evidence Specialist Matsuda") and Garrick Baligad (hereinafter "Evidence Specialist Baligad") responded

- to the Lucky Strike parking lot and Target Store parking structure where they assisted in the recovery of evidence connected to this investigation.
- 29. A single 9mm spent shell casing was recovered near the parking stall of where the shooting had occurred, fronting Lucky Strike. This shell casing was recovered by Evidence Specialist Matsuda and submitted into evidence as item 1 under HPD Report Number 19-340027.
- 30. Evidence Specialist Baligad recovered multiple swabs from blood drops within the Target Store parking structure from the upper Level 2B to Level 2 and the location where Miranda was detained on Kapiolani Boulevard. Based on the injury to Miranda's mouth, it is believed that the blood drops within the parking structure were from Miranda as he fled from the third floor parking lot of where the shooting occurred, into the Target Store parking structure, and out onto Kapiolani Boulevard.
- 31. On September 8, 2019, Judge Summer Kupau-Odo approved a Search Warrant for buccal swab samples from the upper and lower gums, and left and right cheeks inside Miranda's mouth. The swabs were collected by Evidence Specialist Richard Perron and submitted into evidence as item 24 under HPD Report number 19-340027. The swabs recovered from Miranda and the swabs taken from within the Target store parking structure, along with swabs taken from other evidence, are currently being compared and analyzed by the HPD Scientific Investigation Section.
- 32. Scientific Evidence Specialist Bridie Farley (hereinafter "Evidence Specialist Bridie") responded to the scene to assist in the recovery of the firearm discovered in the bed of the Toyota Tacoma pickup truck. Evidence Specialist Bridie recovered and submitted the firearm containing a magazine, five cartridges, and a cartridge casing recovered from the chamber of the firearm and submitted them into evidence as items 3-5, respectively, under HPD Report number 19-340027.
- 33. On September 8, 2019, at approximately 09:00 a.m., Dr. Michael P. Gates (hereinafter "Dr. Gates"), a Medical Examiner, with the City and County Medical Examiner's Office, conducted an external examination on the body of Jennings. Dr. Gates determined the cause of death was a gunshot wound to chest, and the manner of death was determined to be homicide.
- 34. On September 9, 2019, HPD Criminalists, Cindee Lorenzo (hereinafter "Criminalist Lorenzo) tested the cartridge case recovered from the parking lot fronting Lucky Strike, the pistol containing a magazine, the discharged cartridge case recovered from within the pistol, and the five cartridges that were within the magazine, recovered during this investigation and submitted into evidence as items 1, 3, 4, and 5, under HPD Report Number 19340027. Criminalist Lorenzo concluded that the firearm was of an unknown make/model, Glock-type, caliber 9mm Luger, semi-automatic pistol and test fired the firearm and found it to be in operating condition. The detachable box-type magazine that was within the pistol was found to be capable of holding ten (10) caliber 9mm Luger cartridges. Criminalist Lorenzo used one cartridge contained within the magazine recovered within the firearm, and used it to test fire the pistol, and

the cartridge was found to be functional. Furthermore, Criminalist Lorenzo determined that the cartridge case found at the scene, and the cartridge case within the pistol, contained sufficient corresponding individual firing pin aperture signatures, and concluded that the cartridge cases listed as items 1 and 4 under HPD Report number 19340027, were fired within the pistol listed as item 3.

35. On September 9, 2019, Officer Marc Brandt of the HPD Records Division, Firearms Section, conducted a check on Miranda. Miranda did not possess a License to Carry Firearm permit within the City and County of Honolulu, State of Hawaii, on September 8, 2019, and did not have any firearms registered to him on that date.

All of the above occurred in the City and County of Honolulu, State of Hawaii.

WHEREFORE, your affiant respectfully prays that based upon the facts and circumstances contained in this affidavit, a warrant of arrest be issued for the arrest of Kapono J. Miranda for the charges of Murder in the Second Degree, Place to Keep Pistol or Revolver, and Carrying or Use of a Firearm in the Commission of a Separate Felony; that said Kapono J. Miranda be brought forthwith before this Judge or detained subject to the order of this Court or any other Court in which the offense to which the said Kapono J. Miranda is triable for violation of Sections 707-701.5, 143-25, and 134-21 of the Hawaii Revised Statutes;

Detective Donn Manzano hereinafter referred to as the "affiant" first duly sworn on oath, deposes and says:

That he has reason to believe that the offenses of Murder in the Second Degree, Place to Keep Pistol or Revolver, and Carrying or Use of a Firearm in the Commission of a Separate Felony have been committed and that the perpetrator of said offenses is Kapono J. Miranda;

That Murder in the Second Degree is in violation of Sections 707-701.5, Place to Keep Pistol or Revolver is in violation of Section 134-25, and Carrying or Use of a Firearm in the Commission of a Separate Felony is in violation of Section 134-21 of the Hawaii Revised Statutes;

That the facts tending to establish the grounds for the issuance of warrant of arrest for the said Kapono J. Miranda is as follows:

That your affiant is a resident of the City and County of Honolulu, State of Hawaii; that he is a police detective employed by the Honolulu Police Department and has been so employed for over the past 23 years; that he is presently assigned as a detective to the Criminal Investigation Division and has been so assigned for over the past five years; that

your affiant, in the course of performing his assigned duties, has investigated numerous crimes involving felony crimes and has so testified in the Courts of the State of Hawaii;

That your affiant is currently assigned to the Homicide Detail of the Criminal Investigation Division;

On September 8, 2019, your affiant was assigned by Lieutenant Deena Thoemmes to conduct a felony investigation into the arrest of Kapono J. Miranda for Murder in the Second Degree, Place to Keep Pistol or Revolver, and Carrying or Use of a Firearm in the Commission of a Separate Felony under HPD Report Numbers 19-340027-001, 19-340027-002, and 19-340027-003;

That based on your affiant's review of the initial patrol reports, interviews, and follow-up investigations that resulted in the positive identification of Kapono J. Miranda as the suspect in this case, your affiant's investigation to date has determined the following facts, circumstances, and information to the best of my knowledge and belief:

- 1. On September 8, 2019, at about 01:12 a.m., uniformed HPD officers were dispatched to the upper level parking lot of the Ala Moana Shopping Center on a report of two males fighting and that one had been shot. As Officers were enroute to the scene, additional information provided by police dispatch was that one of the men had been shot in the chest.
- 2. The scene was later determined to be the third level parking lot, fronting the Lucky Strike Social Honolulu (hereinafter "Lucky Strike"), located at 1450 Ala Moana Boulevard which is located within the City and County of Honolulu, State of Hawaii.
- 3. Officers arrived and they discovered a large crowd circled around the victim. The victim, later identified as the decedent, Alan Chase Jennings (hereinafter "Jennings"), was found with a single gunshot wound to his upper chest.
- 4. Jennings was taken to Queen's Medical Center where he died of his injuries. Pronouncement of Death was made by Doctor Jae Won Lee at 01:50 a.m. on September 8, 2019.
- 5. HPD Officer Jared Spiker (hereinafter "Officer Spiker") was flagged down by bystanders who immediately told him Jennings had been shot. A female witness, later

- identified as Christine Kaimi (hereinafter "Kaimi") informed Officer Spiker she had recorded the shooting with her cellular phone.
- 6. Kaimi turned over her cellular phone to Officer Spiker which showed the male suspect, later identified as Kapono J. Miranda (hereinafter "Miranda"), wearing a black long sleeve shirt and long blue jean pants.
- 7. Miranda was captured on cellular phone footage pointing what appeared to be a small black handgun in the direction of Jennings who at the time had his hands raised up in the air.
- 8. As the video continued, Miranda who appeared to be standing approximately five feet away from Jennings, appeared to have fired one round in Jennings direction, and Jennings appeared to be struck in the chest. Jennings slouched over, held his chest, and turned away from Miranda and started to run in the opposite direction. Miranda appeared to rack the upper slide of the handgun and shot a second time in the direction of where Jennings had fled out of camera view. Miranda then placed the handgun in his waistband and walked in the opposite direction of Jennings.
- 9. After viewing the cellular phone footage obtained from Kaimi, Officer Spiker updated police dispatch of Miranda's clothing, description, and direction of flight, which appeared to be in the direction of the Target Store. Officer Spiker described Miranda as "a local male wearing a long sleeve black shirt and blue jeans."
- 10. Officer Christopher Nutter (hereinafter "Officer Nutter") who was responding to the scene had heard Officer Spiker's update over the police radio. Officer Nutter checked the Target Store driveway leading out onto Kapiolani Boulevard. He observed a male matching the description given by Officer Spiker, run across the street in front of his subsidized police vehicle.
- 11. Miranda who came from the Makai side of Kapiolani Boulevard, ran across the street towards the parking lot of the First Hawaii Bank, located at 1580 Kapiolani Boulevard. Officer Nutter observed Miranda and immediately pulled his vehicle over and instructed Miranda to sit on the ground near the entrance leading into the bank parking lot.
- 12. As Officer Nutter exited his vehicle, an Ala Moana Security Officer later identified as B.S. Bisaram (hereinafter "Bisaram") informed Officer Nutter he had been following Miranda from the Target Store parking structure.
- 13. Miranda was not cooperative at the time and repeatedly stated to Officer Nutter the he was the victim. Officer Nutter attempted to gather information from Miranda as to the circumstances surrounding the injury to his mouth. Miranda told Officer Nutter "they shot me in the face" and "I'm the fucking victim boss, you guys chasing the wrong guy." Miranda told Officer Nutter "just imagine getting shot in the fact and you guys acting like I'm the criminal." Miranda initially provided his name as what sounded like "Kapono Pao."

- 14. Officer Spiker responded to the bank parking lot where he informed Officer Nutter that the male shooter in the cellular phone footage matched that of Miranda. Officer Nutter then informed Miranda he was being detained.
- 15. Miranda was later identified by his Hawaii State ID by Officer Spiker as "Kapono Miranda."
- 16. Due to the detainment of Miranda as a possible suspect, patrol officers conducted a field show-up, in which multiple witnesses identified Miranda as the male who fired a firearm at Jennings.
- 17. Officer Ryan Seto (hereinafter "Officer Seto") assisted in conducting a sweep of the parking structure and path which Miranda had taken on foot for any possible evidence to the crime. Officer Seto spoke with Security Officer William Moore (hereinafter "Moore") and asked him to point out where he observed Miranda. Officer Seto observed a black a 2017 Toyota Tacoma pickup truck, bearing Hawaii License Plate TTV127 in the area of where Miranda had been seen. Officer Seto observed multiple large drops of what appeared to be blood throughout the parking structure. Officer Seto further observed a black colored "P80" handgun within the bed of the black 2017 Toyota Tacoma. The vehicle was parked within the Mauka Diamond Head NE (Target Parking Lot) level 2B row A, within stall number 15 of 29.
- 18. Upon closer inspection of the handgun, Officer Seto recognized the firearm to be the brand label for a Polymer80, which is a company that sells Glock like plastic frames which can be made into live firing handguns.
- 19. On September 8, 2019, I obtained a recorded statement from Symplee Efhan (hereinafter "Efhan"). Efhan stated that on September 8, 2019, he met up with bunch of his friends including Jennings and Dustin Gapusan (hereinafter "Gapusan") at Lucky Strike at the Ala Moana Shopping Center. Efhan stated that they were waiting outside of Lucky Strike for a friend, when the "one boy," later identified as Miranda, came walking out of Lucky Strike along with two to three other males. Efhan stated that Miranda was walking and "looking dunk" and giving them "stink eye." Efhan stated that Miranda and Jennings were trading words when Miranda told Jennings "Yup, come over here." The males that were with Miranda were told Miranda "let's leave already." Efhan couldn't really see what was going on, but stated that he observed Gapusan hit Miranda. Efhan stated that he saw Miranda look down towards his waist and pull something out. Efhan could only see the butt of the gun. Efhan then ducked as he heard one gunshot and then a second gunshot. Efhan stated that he went around the corner and saw Gapusan trying to pull Jennings towards a car. As Efhan tried to help Jennings, he stated that he observed Miranda running towards the parking structure. Efhan positively identified Miranda to the police as the person that shot at Jennings. Efhan also identified the handgun to Police saying it "seemed like the right gun" recognizing the silver clip on the butt.

- 20. On September 8, 2019, I obtained a recorded statement from Gapusan and he stated that he is friends with Jennings and met him, as well as other friends at Lucky Strike at Ala Moana Shopping Center. Gapusan said about eight of them were waiting outside the door when three boys walked out of Lucky Strike. Gapusan stated that he personally knew two of the males, but had not previously met the male, later identified as Miranda, who was acting aggressively towards them. Miranda was "eyeing up" Jennings and they soon "got into it" and looked as if they were going to fight. The other males who were with Miranda told Gapusan "don't go, he get one gun." Jennings followed Miranda to the parking lot as others were talking about Miranda having a gun. Gapusan followed and observed Miranda playing with his shirt and suspected that Miranda had a gun. Miranda pulled up his shirt and reached into his pants and Gapusan observed the butt of a gun. Gapusan felt threatened and scared for Jennings and felt that he had to intervene. Gapusan hit Miranda and Miranda pulled the gun from his pants. Gapusan stated that he ran and heard two to three gunshots. He looked back and saw Jennings fall on his face on the ground. Gapusan stated that he grabbed Jennings and pulled him next to a car because Jennings had fallen in the middle of the road. Gapusan positively identified Miranda to the police as the person that shot at Jennings. He further identified the handgun to Police saying it "is the same gun he seen on his (Miranda) waist."
- 21. Markette Cadiz-Felton (hereinafter "Cadiz-Felton") provided Officer William Meredith (hereinafter "Officer Meredith") with a written statement. Cadiz-Felton related he was driving within the parking lot near Lucky Strike when he observed an altercation between two males. Cadiz-Felton observed one male throw a punch and the male suspect wearing a "black long sleeve and jeans took a couple steps back and draws a gun from his front waist and shoots two to three times." Cadiz-Felton positively identified Miranda to police as "the male shooter."
- 22. On September 8, 2019, I obtained a recorded statement from Security Officer, Willuth Luther, He stated that at about 0030 hours, he was assigned to secure the area near Lucky Strike. When he was near the front of Lucky Strike he noticed a group of guys surrounding one guy and they were talking about fighting. Luther observed the group walk towards the parking lot. Luther saw one of the guy use his right hand to punch another guy (Miranda) in the mouth. Luther observed Miranda back up a couple steps and reach into his pants under his shirt and pull out his gun. Luther observed Miranda shoot "the guy" (Jennings) that was in front of him. Luther knew that Jennings was shot as he put his hand on his chest. Luther observed smoke on the tip of the barrel of the firearm that Miranda was holding, and also observed that the tip of the firearm was silver. He then heard a second shot and ran for cover. Luther saw Jennings on the ground with people around him, so he went to try and help. Luther identified Maranda to police as the shooter.
- 23. On September 8, 2019, I obtained a recorded statement from Security Officer B. S. Bisaram. He stated on September 8, 2019, he was patrolling near another establishment, Mai Tai Bar, when he heard over the security radio that "somebody just fired off a gun!" Bisaram ran to the area of Lucky Strike and he observed a male, later identified as Miranda, who was wearing a black t-shirt and blue jeans, walking down

the ramp. Bisaram chased after Miranda and caught up to him. Miranda's mouth was bleeding as he told Bisaram "I'm the victim, I'm the victim" and that he had been shot in the mouth. Bisaram tried to grab Miranda's arm but he yanked it back saying "I know my rights, I cannot be detained!" Miranda continued walking and down the ramp toward Kapiolani Blvd., and Bisaram followed Miranda down the ramp to the street. Bisaram saw Officer Nutter and waived him down, at which point Officer Nutter stopped and detained Miranda.

- 24. Amy Villahermosa (hereinafter "Villahermosa") provided Officer Jozlyn Harrington (hereinafter "Officer Harrington") with a handwritten statement. Villahermosa related she was sitting in a car when she observed a tall male, later identified as Miranda, who was wearing a black shirt get punched. Miranda stepped back and pulled a small gun from his pants and shot at the male victim, later identified as Jennings. Villahermosa believed Miranda's first shot may have missed Jennings, in which Miranda fired a few more times. Villahermosa stated that she believed that Jennings was shot, after which, she observed Jennings run away. Villahermosa related Miranda fled the area, as she and her friends performed CPR until a trauma nurse arrived. She positively identified Miranda as the male shooter by his black shirt, tattoos on his neck, and the injury that he sustained to his face. Villahermosa also identified the gun as the same black firearm that she observed in Miranda's pants.
- 25. Shaelyn Borromeo (hereinafter "Borromeo") provided a handwritten statement to Officer Harrington. I also conducted a recorded interview with Borromeo on September 8, 2019. Borromeo related she was on the roof top parking lot next to Lucky Strike with her friend who was videotaping the incident with her cellular phone. Borromeo observed a fight break out, during which she observed a male, later identified as Miranda, back up and pull a gun from his waistband area and shoot once. Borromeo heard and observed Miranda shoot Jennings twice. Borromeo stated that she observed Miranda walk in the direction of Target and approach security guards, point in one direction, and when the security guards drove away, Miranda ran into the parking structure in the opposite direction. Borromeo immediately ran over to Jennings, at which time she applied pressure to his wound. Borromeo positively identified Miranda to police as, "the male that shot the guy." Borromeo identified Miranda through his neck tattoo and his clothing. Borromeo also identified the firearm that was used because it was black and small.
- 26. Based on the witness statements obtained and the positive identification of Miranda as the suspect who shot Jennings, Officer Spiker initially placed Miranda under arrest for Attempted Murder in the Second Degree. It was not until Pronouncement of Death made by Doctor Jae Won Lee at 01:50 a.m., that the Attempted Murder in the Second Degree was reclassified to Murder in the Second Degree.
- 27. Miranda was then informed by Officer Spiker of the reclassification of the offense and that he was now being placed under arrest for Murder in the Second Degree.
- 28. Scientific Evidence Specialist Doryn Matsuda (hereinafter "Evidence Specialist Matsuda") and Garrick Baligad (hereinafter "Evidence Specialist Baligad") responded

- to the Lucky Strike parking lot and Target Store parking structure where they assisted in the recovery of evidence connected to this investigation.
- 29. A single 9mm spent shell casing was recovered near the parking stall of where the shooting had occurred, fronting Lucky Strike. This shell casing was recovered by Evidence Specialist Matsuda and submitted into evidence as item 1 under HPD Report Number 19-340027.
- 30. Evidence Specialist Baligad recovered multiple swabs from blood drops within the Target Store parking structure from the upper Level 2B to Level 2 and the location where Miranda was detained on Kapiolani Boulevard. Based on the injury to Miranda's mouth, it is believed that the blood drops within the parking structure were from Miranda as he fled from the third floor parking lot of where the shooting occurred, into the Target Store parking structure, and out onto Kapiolani Boulevard.
- 31. On September 8, 2019, Judge Summer Kupau-Odo approved a Search Warrant for buccal swab samples from the upper and lower gums, and left and right cheeks inside Miranda's mouth. The swabs were collected by Evidence Specialist Richard Perron and submitted into evidence as item 24 under HPD Report number 19-340027. The swabs recovered from Miranda and the swabs taken from within the Target store parking structure, along with swabs taken from other evidence, are currently being compared and analyzed by the HPD Scientific Investigation Section.
- 32. Scientific Evidence Specialist Bridie Farley (hereinafter "Evidence Specialist Bridie") responded to the scene to assist in the recovery of the firearm discovered in the bed of the Toyota Tacoma pickup truck. Evidence Specialist Bridie recovered and submitted the firearm containing a magazine, five cartridges, and a cartridge casing recovered from the chamber of the firearm and submitted them into evidence as items 3-5, respectively, under HPD Report number 19-340027.
- 33. On September 8, 2019, at approximately 09:00 a.m., Dr. Michael P. Gates (hereinafter "Dr. Gates"), a Medical Examiner, with the City and County Medical Examiner's Office, conducted an external examination on the body of Jennings. Dr. Gates determined the cause of death was a gunshot wound to chest, and the manner of death was determined to be homicide.
- 34. On September 9, 2019, HPD Criminalists, Cindee Lorenzo (hereinafter "Criminalist Lorenzo) tested the cartridge case recovered from the parking lot fronting Lucky Strike, the pistol containing a magazine, the discharged cartridge case recovered from within the pistol, and the five cartridges that were within the magazine, recovered during this investigation and submitted into evidence as items 1, 3, 4, and 5, under HPD Report Number 19340027. Criminalist Lorenzo concluded that the firearm was of an unknown make/model, Glock-type, caliber 9mm Luger, semi-automatic pistol and test fired the firearm and found it to be in operating condition. The detachable box-type magazine that was within the pistol was found to be capable of holding ten (10) caliber 9mm Luger cartridges. Criminalist Lorenzo used one cartridge contained within the magazine recovered within the firearm, and used it to test fire the pistol, and

the cartridge was found to be functional. Furthermore, Criminalist Lorenzo determined that the cartridge case found at the scene, and the cartridge case within the pistol, contained sufficient corresponding individual firing pin aperture signatures, and concluded that the cartridge cases listed as items 1 and 4 under HPD Report number 19340027, were fired within the pistol listed as item 3.

35. On September 9, 2019, Officer Marc Brandt of the HPD Records Division, Firearms Section, conducted a check on Miranda. Miranda did not possess a License to Carry Firearm permit within the City and County of Honolulu, State of Hawaii, on September 8, 2019, and did not have any firearms registered to him on that date.

All of the above occurred in the City and County of Honolulu, State of Hawaii.

Miranda for the charges of Murder in the Second Degree, Place to Keep Pistol or Revolver, and Carrying or Use of a Firearm in the Commission of a Separate Felony; that said Kapono J. Miranda be brought forthwith before this Judge or detained subject to the order of this Court or any other Court in which the offense to which the said Kapono J. Miranda is triable for violation of Sections 707-701.5, 143-25, and 134-21 of the Hawaii Revised Statutes;

Miranda appeared to rack the upper slide of the handgun and shot a second time in the direction of where Jennings had fled out of camera view. Miranda then placed the handgun in his waistband and walked in the opposite direction of Jennings.
- 9. After viewing the cellular phone footage obtained from Kaimi, Officer Spiker updated police dispatch of Miranda's clothing, description, and direction of flight, which appeared to be in the direction of the Target Store. Officer Spiker described Miranda as "a local male wearing a long sleeve black shirt and blue jeans."
- 10. Officer Christopher Nutter (hereinafter "Officer Nutter") who was responding to the scene had heard Officer Spiker's update over the police radio. Officer Nutter checked the Target Store driveway leading out onto Kapiolani Boulevard. He observed a male matching the description given by Officer Spiker, run across the street in front of his subsidized police vehicle.
- 11. Miranda who came from the Makai side of Kapiolani Boulevard, ran across the street towards the parking lot of the First Hawaii Bank, located at 1580 Kapiolani Boulevard. Officer Nutter observed Miranda and immediately pulled his vehicle over and instructed Miranda to sit on the ground near the entrance leading into the bank parking lot.
- 12. As Officer Nutter exited his vehicle, an Ala Moana Security Officer later identified as B.S. Bisaram (hereinafter "Bisaram") informed Officer Nutter he had been following Miranda from the Target Store parking structure.
- 13. Miranda was not cooperative at the time and repeatedly stated to Officer Nutter the he was the victim. Officer Nutter attempted to gather information from Miranda as to the circumstances surrounding the injury to his mouth. Miranda told Officer Nutter "they shot me in the face" and "I'm the fucking victim boss, you guys chasing the wrong guy." Miranda told Officer Nutter "just imagine getting shot in the fact and you guys acting like I'm the criminal." Miranda initially provided his name as what sounded like "Kapono Pao."

- 14. Officer Spiker responded to the bank parking lot where he informed Officer Nutter that the male shooter in the cellular phone footage matched that of Miranda. Officer Nutter then informed Miranda he was being detained.
- 15. Miranda was later identified by his Hawaii State ID by Officer Spiker as "Kapono Miranda."
- 16. Due to the detainment of Miranda as a possible suspect, patrol officers conducted a field show-up, in which multiple witnesses identified Miranda as the male who fired a firearm at Jennings.
- 17. Officer Ryan Seto (hereinafter "Officer Seto") assisted in conducting a sweep of the parking structure and path which Miranda had taken on foot for any possible evidence to the crime. Officer Seto spoke with Security Officer William Moore (hereinafter "Moore") and asked him to point out where he observed Miranda. Officer Seto observed a black a 2017 Toyota Tacoma pickup truck, bearing Hawaii License Plate TTV127 in the area of where Miranda had been seen. Officer Seto observed multiple large drops of what appeared to be blood throughout the parking structure. Officer Seto further observed a black colored "P80" handgun within the bed of the black 2017 Toyota Tacoma. The vehicle was parked within the Mauka Diamond Head NE (Target Parking Lot) level 2B row A, within stall number 15 of 29.
- 18. Upon closer inspection of the handgun, Officer Seto recognized the firearm to be the brand label for a Polymer80, which is a company that sells Glock like plastic frames which can be made into live firing handguns.
- 19. On September 8, 2019, I obtained a recorded statement from Symplee Efhan (hereinafter "Efhan"). Efhan stated that on September 8, 2019, he met up with bunch of his friends including Jennings and Dustin Gapusan (hereinafter "Gapusan") at Lucky Strike at the Ala Moana Shopping Center. Efhan stated that they were waiting outside of Lucky Strike for a friend, when the "one boy," later identified as Miranda, came walking out of Lucky Strike along with two to three other males. Efhan stated that Miranda was walking and "looking dunk" and giving them "stink eye." Efhan stated that Miranda and Jennings were trading words when Miranda told Jennings "Yup, come over here." The males that were with Miranda were told Miranda "let's leave already." Efhan couldn't really see what was going on, but stated that he observed Gapusan hit Miranda. Efhan stated that he saw Miranda look down towards his waist and pull something out. Efhan could only see the butt of the gun. Efhan then ducked as he heard one gunshot and then a second gunshot. Efhan stated that he went around the corner and saw Gapusan trying to pull Jennings towards a car. As Efhan tried to help Jennings, he stated that he observed Miranda running towards the parking structure. Efhan positively identified Miranda to the police as the person that shot at Jennings. Efhan also identified the handgun to Police saying it "seemed like the right gun" recognizing the silver clip on the butt.

- 20. On September 8, 2019, I obtained a recorded statement from Gapusan and he stated that he is friends with Jennings and met him, as well as other friends at Lucky Strike at Ala Moana Shopping Center. Gapusan said about eight of them were waiting outside the door when three boys walked out of Lucky Strike. Gapusan stated that he personally knew two of the males, but had not previously met the male, later identified as Miranda, who was acting aggressively towards them. Miranda was "eyeing up" Jennings and they soon "got into it" and looked as if they were going to fight. The other males who were with Miranda told Gapusan "don't go, he get one gun." Jennings followed Miranda to the parking lot as others were talking about Miranda having a gun. Gapusan followed and observed Miranda playing with his shirt and suspected that Miranda had a gun. Miranda pulled up his shirt and reached into his pants and Gapusan observed the butt of a gun. Gapusan felt threatened and scared for Jennings and felt that he had to intervene. Gapusan hit Miranda and Miranda pulled the gun from his pants. Gapusan stated that he ran and heard two to three gunshots. He looked back and saw Jennings fall on his face on the ground. Gapusan stated that he grabbed Jennings and pulled him next to a car because Jennings had fallen in the middle of the road. Gapusan positively identified Miranda to the police as the person that shot at Jennings. He further identified the handgun to Police saying it "is the same gun he seen on his (Miranda) waist."
- 21. Markette Cadiz-Felton (hereinafter "Cadiz-Felton") provided Officer William Meredith (hereinafter "Officer Meredith") with a written statement. Cadiz-Felton related he was driving within the parking lot near Lucky Strike when he observed an altercation between two males. Cadiz-Felton observed one male throw a punch and the male suspect wearing a "black long sleeve and jeans took a couple steps back and draws a gun from his front waist and shoots two to three times." Cadiz-Felton positively identified Miranda to police as "the male shooter."
- 22. On September 8, 2019, I obtained a recorded statement from Security Officer, Willuth Luther, He stated that at about 0030 hours, he was assigned to secure the area near Lucky Strike. When he was near the front of Lucky Strike he noticed a group of guys surrounding one guy and they were talking about fighting. Luther observed the group walk towards the parking lot. Luther saw one of the guy use his right hand to punch another guy (Miranda) in the mouth. Luther observed Miranda back up a couple steps and reach into his pants under his shirt and pull out his gun. Luther observed Miranda shoot "the guy" (Jennings) that was in front of him. Luther knew that Jennings was shot as he put his hand on his chest. Luther observed smoke on the tip of the barrel of the firearm that Miranda was holding, and also observed that the tip of the firearm was silver. He then heard a second shot and ran for cover. Luther saw Jennings on the ground with people around him, so he went to try and help. Luther identified Maranda to police as the shooter.
- 23. On September 8, 2019, I obtained a recorded statement from Security Officer B. S. Bisaram. He stated on September 8, 2019, he was patrolling near another establishment, Mai Tai Bar, when he heard over the security radio that "somebody just fired off a gun!" Bisaram ran to the area of Lucky Strike and he observed a male, later identified as Miranda, who was wearing a black t-shirt and blue jeans, walking down

the ramp. Bisaram chased after Miranda and caught up to him. Miranda's mouth was bleeding as he told Bisaram "I'm the victim, I'm the victim" and that he had been shot in the mouth. Bisaram tried to grab Miranda's arm but he yanked it back saying "I know my rights, I cannot be detained!" Miranda continued walking and down the ramp toward Kapiolani Blvd., and Bisaram followed Miranda down the ramp to the street. Bisaram saw Officer Nutter and waived him down, at which point Officer Nutter stopped and detained Miranda.

- 24. Amy Villahermosa (hereinafter "Villahermosa") provided Officer Jozlyn Harrington (hereinafter "Officer Harrington") with a handwritten statement. Villahermosa related she was sitting in a car when she observed a tall male, later identified as Miranda, who was wearing a black shirt get punched. Miranda stepped back and pulled a small gun from his pants and shot at the male victim, later identified as Jennings. Villahermosa believed Miranda's first shot may have missed Jennings, in which Miranda fired a few more times. Villahermosa stated that she believed that Jennings was shot, after which, she observed Jennings run away. Villahermosa related Miranda fled the area, as she and her friends performed CPR until a trauma nurse arrived. She positively identified Miranda as the male shooter by his black shirt, tattoos on his neck, and the injury that he sustained to his face. Villahermosa also identified the gun as the same black firearm that she observed in Miranda's pants.
- 25. Shaelyn Borromeo (hereinafter "Borromeo") provided a handwritten statement to Officer Harrington. I also conducted a recorded interview with Borromeo on September 8, 2019. Borromeo related she was on the roof top parking lot next to Lucky Strike with her friend who was videotaping the incident with her cellular phone. Borromeo observed a fight break out, during which she observed a male, later identified as Miranda, back up and pull a gun from his waistband area and shoot once. Borromeo heard and observed Miranda shoot Jennings twice. Borromeo stated that she observed Miranda walk in the direction of Target and approach security guards, point in one direction, and when the security guards drove away, Miranda ran into the parking structure in the opposite direction. Borromeo immediately ran over to Jennings, at which time she applied pressure to his wound. Borromeo positively identified Miranda to police as, "the male that shot the guy." Borromeo identified Miranda through his neck tattoo and his clothing. Borromeo also identified the firearm that was used because it was black and small.
- 26. Based on the witness statements obtained and the positive identification of Miranda as the suspect who shot Jennings, Officer Spiker initially placed Miranda under arrest for Attempted Murder in the Second Degree. It was not until Pronouncement of Death made by Doctor Jae Won Lee at 01:50 a.m., that the Attempted Murder in the Second Degree was reclassified to Murder in the Second Degree.
- 27. Miranda was then informed by Officer Spiker of the reclassification of the offense and that he was now being placed under arrest for Murder in the Second Degree.
- 28. Scientific Evidence Specialist Doryn Matsuda (hereinafter "Evidence Specialist Matsuda") and Garrick Baligad (hereinafter "Evidence Specialist Baligad") responded

- to the Lucky Strike parking lot and Target Store parking structure where they assisted in the recovery of evidence connected to this investigation.
- 29. A single 9mm spent shell casing was recovered near the parking stall of where the shooting had occurred, fronting Lucky Strike. This shell casing was recovered by Evidence Specialist Matsuda and submitted into evidence as item 1 under HPD Report Number 19-340027.
- 30. Evidence Specialist Baligad recovered multiple swabs from blood drops within the Target Store parking structure from the upper Level 2B to Level 2 and the location where Miranda was detained on Kapiolani Boulevard. Based on the injury to Miranda's mouth, it is believed that the blood drops within the parking structure were from Miranda as he fled from the third floor parking lot of where the shooting occurred, into the Target Store parking structure, and out onto Kapiolani Boulevard.
- 31. On September 8, 2019, Judge Summer Kupau-Odo approved a Search Warrant for buccal swab samples from the upper and lower gums, and left and right cheeks inside Miranda's mouth. The swabs were collected by Evidence Specialist Richard Perron and submitted into evidence as item 24 under HPD Report number 19-340027. The swabs recovered from Miranda and the swabs taken from within the Target store parking structure, along with swabs taken from other evidence, are currently being compared and analyzed by the HPD Scientific Investigation Section.
- 32. Scientific Evidence Specialist Bridie Farley (hereinafter "Evidence Specialist Bridie") responded to the scene to assist in the recovery of the firearm discovered in the bed of the Toyota Tacoma pickup truck. Evidence Specialist Bridie recovered and submitted the firearm containing a magazine, five cartridges, and a cartridge casing recovered from the chamber of the firearm and submitted them into evidence as items 3-5, respectively, under HPD Report number 19-340027.
- 33. On September 8, 2019, at approximately 09:00 a.m., Dr. Michael P. Gates (hereinafter "Dr. Gates"), a Medical Examiner, with the City and County Medical Examiner's Office, conducted an external examination on the body of Jennings. Dr. Gates determined the cause of death was a gunshot wound to chest, and the manner of death was determined to be homicide.
- 34. On September 9, 2019, HPD Criminalists, Cindee Lorenzo (hereinafter "Criminalist Lorenzo) tested the cartridge case recovered from the parking lot fronting Lucky Strike, the pistol containing a magazine, the discharged cartridge case recovered from within the pistol, and the five cartridges that were within the magazine, recovered during this investigation and submitted into evidence as items 1, 3, 4, and 5, under HPD Report Number 19340027. Criminalist Lorenzo concluded that the firearm was of an unknown make/model, Glock-type, caliber 9mm Luger, semi-automatic pistol and test fired the firearm and found it to be in operating condition. The detachable box-type magazine that was within the pistol was found to be capable of holding ten (10) caliber 9mm Luger cartridges. Criminalist Lorenzo used one cartridge contained within the magazine recovered within the firearm, and used it to test fire the pistol, and

the cartridge was found to be functional. Furthermore, Criminalist Lorenzo determined that the cartridge case found at the scene, and the cartridge case within the pistol, contained sufficient corresponding individual firing pin aperture signatures, and concluded that the cartridge cases listed as items 1 and 4 under HPD Report number 19340027, were fired within the pistol listed as item 3.

35. On September 9, 2019, Officer Marc Brandt of the HPD Records Division, Firearms Section, conducted a check on Miranda. Miranda did not possess a License to Carry Firearm permit within the City and County of Honolulu, State of Hawaii, on September 8, 2019, and did not have any firearms registered to him on that date.

All of the above occurred in the City and County of Honolulu, State of Hawaii.

WHEREFORE, your affiant respectfully prays that based upon the facts and circumstances contained in this affidavit, a warrant of arrest be issued for the arrest of Kapono J. Miranda for the charges of Murder in the Second Degree, Place to Keep Pistol or Revolver, and Carrying or Use of a Firearm in the Commission of a Separate Felony; that said Kapono J. Miranda be brought forthwith before this Judge or detained subject to the order of this Court or any other Court in which the offense to which the said Kapono J. Miranda is triable for violation of Sections 707-701.5, 143-25, and 134-21 of the Hawaii Revised Statutes;
